	Para 3.2 of committee report incorrectly states that for the 'Full' part of the application, other than the proposed Tesco, costa and home bargains store the rest of the units are spread across 9 units when it is in fact 7 units. Across both Full and Outline parts there are 12 units in total, albeit the outline units are not finalised until the Reserved Matters submission.
	We have received 5 letters of support and 1 letter of objection as late representations after the committee agenda was finalised which are summarised as follows:

	<ul> <li>From Costa Coffee <ul> <li>Will generate numerous job opportunities for the local community.</li> <li>Northfields Park presents a remarkable opportunity for Louth to enhance its retail offerings, support local employment, and bolster the economy.</li> </ul> </li> </ul>
	<ul> <li>From Home Bargains</li> <li>Proposed Home Bargains store would create approximately 100 new full and part time jobs which would be focused on the local area.</li> <li>New Home Bargains store will result in an investment of circa £5million to the local economy.</li> <li>Would be first Home Bargains store in Louth.</li> </ul>

In objection:</li> <li>From Peacock and Smith on behalf of Morrisons <ul> <li>Conflict with para 89 of the NPPF and SP14</li> <li>Application site is safeguarded for employment use and the Applicant has not offered justification for retail uses.</li> <li>Para 7.32 of committee report is not correct as impact of Tesco, home bargains and costa have been underestimated on the town centre.</li> </ul> </li> <li>3. We have received a late representation from the Applicants Agent stating: "Co-Op have sub-let part of their Northgate store in Louth to Bonmarché and undertook a full refurbishment of the store over the summer which they feel confirms Co-Op's commitment to Louth, and further reduces the, already unlikely, chances of the store closing as a result of the Northfields development".</li> </ul>
