- 9. The reason for the decision and other alternative options considered and rejected:

The Council has a large number of natural gas and some oil heating appliance installations providing core central heating, hot water and swimming pool services across a range of core Public Buildings such as offices, industrial premises and Leisure assets

The inspection, servicing and maintenance of this equipment is a statutory duty and an essential part of the planned and cyclical maintenance programme to ensure systems are running reliable, safe and confirming to current regulations.

Economies of scale have been obtained in an open procurement exercise which has resulted in five competitive priced bids being received for the callout, servicing and maintenance works through an agreed fixed schedule of rates for three years with the option to extend for a further 2 years dependant on key performance indicators.

It is therefore recommended the lowest economically advantageous bid received which was assessed on a 60/40% quality / price ratio score for the sum of £24,757 per annum be accepted and a formal contract entered into with the successful Contractor. The Tender scoring evaluation was submitted to the S151 Officer and Portfolio Holder for Finance for review.

The above cost contains a number or priced schedule of rate items which may or may not be used during the contract duration, therefore where possible, these will be omitted thus providing a saving.
