9. The reason for the decision and other alternative options considered and rejected:

The extension of serviced employment land at the Fairfield Industrial Estate in Louth is included in the Council's Economic Action Plan and Asset Management Framework.

ELDC require the services of a Civil Engineer and a Quantity Surveyor to provide an initial design and costing for the proposed access road. Gleeds will manage the process and provide a cost plan to include Topographical Survey, Highway Design, Road Lighting Design, Drainage Strategy, Culvert Design and Utilities Assessment. AECOM will undertake preliminary design of a serviced corridor to accommodate future development of the site. By definition, the serviced corridor will comprise a 7.3 metre wide estate road, with footways, road lighting and drainage, which will extend from the current end of Nottingham Road to the end of the 10 acre site. The design will be developed in sufficient detail to enable a construction cost plan to be developed which will inform East Lindsey District Council about the viability of site development.

It is proposed that Perfect Circle are appointed by the Council, under the national Built Environment Consultancy Services (BECS) Framework, via the Scape Procure Group. Scape Procure have designed frameworks to deliver outcomes that are economically advantageous and quality assured. They also remove the need for clients to carry out their own OJEU procurement.

The framework is therefore intended to deliver the fastest route to the appointment of a qualified supplier, rather than pursuing other procurement options.
