9. The reason for the decision and other alternative options considered and rejected: Under a previous Executive Decision Notice M.A.P. Security were appointed to provide security to the former Roughton Moor Camp on Kirkby Lane, Woodhall Spa. The remit of the security personnel has been to patrol the site where Mustard Gas compound had been found and removed in September/October 2017 and to assist with any road closures that have been needed to be put in place. The increase from 2 to 3 personnel is to facilitate the final phase of Operation Saddleback to enable officers from the Ministry of Defence to maximise their operations during daylight hours by establishing a 24 hour road closure at either end of the site, allowing for the appropriate rest breaks for the security personnel.

Funded from:- Emergency Planning budget within the Public Protection Service, to be reimbursed by the Ministry of Defence.




