YES. DWP will pay ELDC £26,143 from 1 April 2018 – 31 March 2019 to support claimants in the transition to Universal Credit full service.

50% of annual funding allocation will be paid in April 2018, then quarterly payments based on actual take-up above 50% allocation. Case load above 120% of quarterly estimate will be reviewed by DWP on a case by case basis.

9. The reason for the decision and other alternative options considered and rejected:

Universal Credit 'live service' has been available for some East Lindsey residents since November 2015. During 2018, Universal Credit 'full service' will become available for all claimants in East Lindsey.

With a change to single monthly payments, some claimants have needed personal budgeting support or help to access the digital service. DWP have funded ELDC to provide this. Those referred are likely to come into contact with ELDC already, providing an opportunity for preventative support for residents.

The grant agreement states ELDC are able to utilise the expertise of third parties provided that agreed Universal Support delivery partners are qualifying persons as detailed in the Social Security Regulations 2015 and that DWP are provided with their details. This allows ELDC to refer or signpost claimants to more suitable organisations where appropriate.

It has also been helpful during the term of the previous DWP Partnership Agreement (1 April 2017 -31 March 2018) to identify clients with complex budgeting needs early before they are at risk of rent arrears and/or eviction to support homelessness prevention.
