9. The reason for the decision and other alternative options considered and rejected:

Due to the emerging concerns around structural issues with the colonnade at Sutton on Sea, the beach chalets on top of the colonnade need removing to reduce the weight on top of the structure. The private chalet owners have an annual licence with the Council to enable them to site their chalets on Council property, and under this tenancy agreement the Council has to give formal notice to the licencees requiring them to give back the site with vacant possession. This Notice to Quit enables the Council to gain vacant possession of the sites on 31st March 2019, to reduce the health and safety risk to chalet owners and users, and to enable works to be undertaken to the Colonnade.

To assist the beach chalet owners with the relocation or removal of individual chalets, East Lindsey District Council will offer a single ex-gratia payment of up to £500 per beach chalet to owners of chalets numbered 30-39 only.


