Planning enquiries in 2015 suggested the land is unsuitable for residential development. ELDC has received interest in purchasing the land for amenity use. The land is not included within any prospective asset transfer schedule to Horncastle Town Council. ELDC's asset management plan dictates that surplus assets be identified and disposed of at best consideration where appropriate. Given that the land is not fulfilling any operational purpose and does not provide any income it is appropriate for the copse to be declared surplus and sold to achieve best consideration.


The alternative is to retain the asset or transfer to town council. No approaches for an asset transfer have been received. To retain the asset would be contrary to the asset management framework policy.
