Having undertaken a review of occupancy rates, commercial use of the Centre's facilities and the operational expenditure over recent years, the changes are focussed on seeking to increase the appeal of the Business Centre as a business location and making the premises more affordable for current and future tenants through more efficient management arrangements and a reduction in the associated service charges to tenants. As part of this process, Banks Long & Co have already been appointed to increase

marketing of the Centre's facilities through additional online promotion, a new Estate sales board and direct mailshots within their client base. This has already generated some additional enquires, with interest in six vacant units currently being progressed by the Business Centre team.

Under the new arrangements, the Mablethorpe Business Centre will continue to be operated by the Council, but we will move towards the removal of a dedicated on-site reception facility at Mablethorpe with all existing tenant services to be provided and managed remotely through the team at the Fairfield Enterprise Centre in Louth. In order to support this process, a number of additional investments will be made to enhance onsite access and security arrangements at Mablethorpe. These works are expected to commence in December, with a view to the revised charges being operational from the $1^{\rm st}$ April 2019.

All of the Business Centre staff and tenants have been informed of the proposed changes and operational implications. Subject to approval, the proposals will result in a reduction to the current advertised charges for all units within the Centre.
