Since September 2017 Coastal Events Community Interest Company (CIC) have had the opportunity to seek external funding and to develop a business plan to allow East Lindsey District Council to transfer the Boatshed asset to the Coastal Events CIC.

Following a review of progress regarding this matter in November 2018 East Lindsey District Council asked the Coastal Events CIC to submit a final business plan in connection with this matter by no later than the end of February 2019.

A business plan submitted by Coastal Events CIC on 22nd February 2019. This business plan has been externally evaluated as weak. A further

response submitted by the Coastal Events CIC after the Focus evaluation was shared with the group been further evaluated. This has not changed the original assessment of the original business plan as weak.

Alternatives to a transfer to the CIC would be to continue with the Town Council as tenant responsible for the remaining 77 years of their term or to take an early surrender of their lease conditional on obtaining a freehold sale on the open market. Mablethorpe Town Council have indicated they are seeking an early surrender of their lease subject to a successful sale on the open market.
