- 9. The reason for the decision and other alternative options considered and rejected:

The Council have issued two Section 215 Notices on 8.2.18 and 9.11.18 requiring the land to be tidied as the Council consider that it is visually detrimental to the area. The property is empty and the registered owner is deceased. Direct action was taken previously to secure that the requirements of the notices were complied with and a cost was placed as a land charge The property is now going through an 'Enforced sale' procedure to secure the sale of the property and Council will receive the monies owed, back.

The enforced sale process is taking longer than anticipated due to existing mortages and debts also registered against the property. In the meantime, the front garden has become very overgrown again and the back door has been vandalised leaving the property insecure. The Council is continuing to receive complaints about this and the appearance in the street scene.

It is proposed that the Council will engage the services of an external contractor again to tidy the front garden area only and board over the back doors to secure it. But in the absence of further notices being issued it will not secure the money for this when the property is sold. This action is proposed due to the exceptional circumstances in regard to this property and the complexity of the enforced sale as a result of this. Also due to the longer time period to resolve this matter and fully dispose of the property.
