9. The reason for the decision and other alternative options considered and rejected:

The District Council has been occupying the public conveniences located adjacent to Huttoft Car Terrace under licence from Lincolnshire County Council since November 1966.

The County Council has a wider plan to enhance this location by removing their existing boatshed and replace it with a new café, with a rooftop terrace and ground level deck. The proposal includes the refurbishment of

the existing public toilets within the project, to be managed by a local operator.

To fulfil their plans to remodel and improve the provision at this location, in October 2019 LCC issued ELDC with a notice to teminate the licence with effect from 7th May 2020.

The County Council consulted with the Parish, District and County Councillors in June 2019.

Approving the disposal of this asset to the County Council enables this area to be improved and provides a small saving to the district council by no longer providing supplies, or maintaining and cleaning the toilets.

Althought the notice to quit is with effect from May 2020, the County Council wishes to begin the redevelopment on the 24th Febrary 2020, and therefore we propose to deliver possession to LCC as soon as possible to enable the works to take place.
