The parcel of land is public open space of approx. 0.7ha acquired as part of a S106 Planning Application in 1990. This was omitted from the schedule of assets approved for transfer to Skegness Town Council in the report of 5^{th} December 2018 as it had not been correctly recorded within ELDC asset records at the time of transfer. Had it been so it would have formed part of the Phase II contract and transfers of 31^{st} October 2019 which included other similar ares of public open space more suitable for management at a local level, The land has a nominal value of £1.00. The

proposed transfer is the most cost effective and , because of the previous transfers, the most effective operational way for the site to be managed. Skegness Town Council considered this at their meeting of $15^{\rm th}$ January 2020 and agreement to the acceptance of a transfer was recorded.
