Applications that are for Major development

Applications in a Conservation Area (or affecting the character or appearance of)

Applications for Listed Building Consent or Ancient Monument Consent (or affecting the setting of)

Application under s.73 or a condition discharge application attached to a listed building consent

Applications that are EIA applications

Applications that are publicised as a Departure from the Development

Applications that impact on a public right of way

Applications for works to trees the subject of a Tree Preservation Order Applications under all categories of 'prior approval'

The arrangements for notifying adjoining neighbours will therefore continue as set out under the 'Telling the neighbours' heading below and are unaffected by this temporary change.

- 2. For the duration of this temporary variation the Council's Statement of Community Involvement (SCI) November 2016, Part 2 Chapter 8 has been amended in all the relevant places by this change.
- 3. This temporary variation is to remain in place for 6 months or until the Council resolves to reinstate the SCI as it stands immediately prior to the variation, whichever is the sooner.
