9. The reason for the decision and other alternative options considered and rejected:

Bulky waste is collected in refuse collection vehicles on the regular collection rounds and bulky white goods are collected by a separate vehicle. Suspending collections while the new rounds are being introduced provides more capacity for the refuse collection vehicles to take excess waste generated by those households negatively impacted by the change in collection day. It also enables more drivers to be available to support the provision of kerbside wheeled bin collections at a time when the service is under increased risk and pressures due to COVID-19.

The only other disposal option for residents are the Household Waste Recycling Centres, however these are also closed at the current time.

Those residents who had already paid for a bulky waste collections will still have their items collected.
