A partnership submission via GLEEN (Greater Lincolnshire Energy Efficiency Network) was successful, leading to the development of a project which includes a range of options to improve the heating and energy efficiency of properties across Greater Lincolnshire. An information sharing agreement is in place. The project will be led and coordinated by North Lincs Council on behalf of GLEEN. Reporting to the Lincolnshire District Housing Network wil take place and the approach will remain a collaborative one.

The Warm Homes fund required an element of match funding. All Lincolnshire District Councils have committed to provide funding to enable Gas and LPG central heating installation for a limited number of properties in their local area. This is an important step in addressing fuel poverty and the resource will be targeted at households experiencing fuel poverty and associated long term health conditions. This project will directly support Better Care Fund outcomes.
