- 9. The reason for the decision and other alternative options considered and rejected:
 - The service has approximately £45,000 of capital approved by Executive Board (EB) for the purchase of plant and vehicles to develop and resource a Pride In East Lindsey team this team will support the Council in being able to provide a higher level of cleansing in local hot spot areas, to help to engage the local community, and stimulate behaviour change around keeping local environments clean.
 - Due to the ongoing turbulent economic and supply situation the original vehicle specified and agreed by EB has increased in price

Decision Notice Form (ExD2)

(approx. 10,000) with a 12-18 months lead time for delivery. This timeframe would not enable the Pride in ELDC team operating through 2022.

- The service has worked with the Fleet Manager to look at alternative vehicle and plant options, with shortened delivery times. We have sourced suitable alternatives that will enable the Pride in East Lindsey team to operate from Autumn 2022, at the latest.
- An added benefit of the alternative vehicle and plant configuration is that the solution will provide better flexibility of use and increase
 the amount the team will be able to operate without unnecessary
 downtime.
- This alternative option will cost an additional £18,000.
- The finance team has confirmed there is authorised capital finance underspend from a previous fleet capital bid - which could be utilised to support the delivery of this project.
- This will negate the need to secure new additional funding to deliver this project.
- We could continue with the original proposals agreed with EB with increased costs. However, this project will be significantly delayed and a decision would have to be made to secure funds for the additional estimated £10,000 for the original proposal.
