The Council have issued a Section 215 Notices on 15th July 2022 requiring the land to be tidied as the Council consider that it is visually detrimental to the area. This was not complied with and the occupiers behaviour continued which ccontributed to the untidy land getting worse. The Council further issued x2 Community Protection Warning letters on on 2nd March 2022 and on 9th November 2022, followed by a Community Protection Notice on 15th December 2022. The owner has still failed to comply.

It is proposed that the Council will engage the services of an external contractor to carry out the steps specified in the notice to tidy the site and charge the cos back to the property as a land charge. This action is proposed as it will resolve the complaints at the site. The Council does not consider it to be in the public interest to prosecute for non-compliance due to the personal circumstances of the occupier (which are confidential) and because the Court cannot make the owner comply so it would not reolve the problem at the site.
