None of the other proposed places stand out as problematic	Whilst KEVIS Sports Hall has been suggested as an alternative, this was used previously and moved to KEVIS Foundation House. The location/parking and safeguarding was a concern. The Boars Head Pub was considered a suitable alterative, we have the use of the back room which is separate from the main public area, and this has a disabled ramp and rail. There are three car parks that border the pub for convenient public access. It is therefore proposed to remain at the Boars Head, Louth.
Cllr R Jackson	Royal British Legion, Louth The Royal British Legion Hall in Northgate, Louth has been closed by the RBL due to structural issues and condemned. From discussions I've had with local members it seems like the repairs will be extensive and expensive - minimum of £250,000 estimated about 4 years ago, and likely the price will have risen quite a bit. So there's no realistic expectation that it can be used as a polling place in the next couple of years. It's going to take time to raise that kind of money, and then to make the repairs - assuming the RBL is amenable to that course of action, which isn't guaranteed. Long story short, you will need to find an alternative polling place. The library	An alternative venue is required for this polling station. Louth Library has adequate space, but no direct parking and the room is located upstairs. The Sessions House has been suggested, it has a large private car park and disabled ramp access. After an assessment of the building, it is proposed to move the polling station to the Sessions House, Eastgate, Louth.

They currently are sent to Alvingham Village Hall to vote, three miles away. I do not anticipate that many voters will make the effort to drive out to Alvingham to cast their vote from these streets. Whilst postal voting is an option, I would like to see if it can be considered an option for voters to be allowed to vote at one of the Polling Stations in Louth. It may be that this would need extra vigilance by the polling clerks and ballot papers would have to be separated at the count, but I do not see these as insurmountable problems.
