9. The reason for the decision and other alternative options considered and rejected:

To enable a partnership wide leisure operator procurement process to be undertaken in a timely manner to meet partner contract timeline requirements in accordance with the annual delivery plan 2023/24; and

To enable the ELDC facilities to be included.

Other alternative options considered and rejected:

ELDC not participating in the procurement project has been considered and rejected on the basis that not doing so would be contrary to the agreed SELCP Sub-Regional Strategy and annual plan 2023/24.

Progressing the procurement process with ELDC venues included but without giving notice to Magna Vitae has also been considered. Legal advice has determined that such an approach could leave the Council open to significant legal challenge due to the current FMA contract commitments. The advice explained that in order to be able to publish a tender that includes ELDC venues, a termination notice needs to have been served in respect of the current contract.

The support costs associated with the SELCP procurement project, both in terms of external specification (contracts, leases, tender documentation drafting and legal execution) and internal project management (by the Head of Special Projects, Leisure), as would be attributable to ELDC's participation in the process, are estimated to be in the region of £80k.
