The reason for the decision and other alternative options considered and rejected: On 27th March 2024 the Department for Levelling Up, Housing and Communities (now Ministry of Housing, Communities and Local Government (MHCLG)) selected East Lindsey District Council as a Treatment Group for a Healthy Homes Pilot, focusing on reducing the prevalence of damp and mould growth in the private sector. The amount of grant award for a treatment group is £130,000. Under the terms of the grant award the Council is required to evidence how it will:
 - I. Provide additional resource in enforcement teams
 - II. Standardise training across your existing team.
 - III. Improved communications and engagement with landlords and tenants.
 - IV. Improved equipment, i.e., tools to measure damp and mould; and
 - V. Improved data collection tools and support.

All of the above is required to be completed by 31st March 2025, however due to delays in the project caused by the recent general election the key performance indicators that the Council is expected to be reporting against have yet to be published. Within Lincolnshire the Good Homes Alliance has recently been developed to deliver advice and help to residents for a whole range of housing related issues, including damp and mould growth. It is proposed to allocate up to £130,000 of the funding received to the Good Homes Alliance to deliver on the items listed I – V above. The funding would provide dedicated resources specifically for the East Lindsey area, in order to deliver on the pilot. This will provide longevity and a more sustainable approach to the delivery of this work, as the Good Homes Alliance will continue operating beyond the end of the MHCLG Healthy Homes pilot.
